ORDINANCE NO. 20-07

**ORDINANCE AMENDING THE TRAFFIC CODE TO PERMIT PARKING WHERE
CURB IS PAINTED YELLOW,
AT SPECIFIC LOCATION AND FOR SPECIFIC PURPOSE**

WHEREAS, the Village of New Lexington has previously enacted a Traffic Code, identified and referred to as the Codified Ordinances of New Lexington, Part Three – Traffic Code, within which are provisions controlling Parking, identified and referred to as Title Seven – Parking, within which is Chapter 351 Parking Generally, within which is Section 351.03 – Prohibited Standing or Parking Places, all being effective pursuant to Ordinance No. 09-08;

WHEREAS, the Village of New Lexington desires to amend and supplement Section 351.03 – Prohibited Standing or Parking Places, specifically Provision (a)(14), prohibiting parking “[a]t any place where signs prohibit stopping, standing or parking, or where the curbing or street is painted yellow, or at any place in excess of the maximum time limited by signs;” only to the extent necessary to add an exception thereto permitting parking where curbing is painted yellow upon West Water Street at Main Street in front of the Catholic Church, for elderly and/or physically disabled persons in attendance at said Church, during and for a period of thirty (30) minutes immediately preceding and for a period of thirty (30) minutes immediately following, services and events at said Church.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village of New Lexington, Perry County, State of Ohio, that:

1. Ordinance No. 09-08, Codified Ordinances of New Lexington, Part Three – Traffic Code, Title Seven – Parking, Chapter 351 Parking Generally, Section 351.03(a)(14), is hereby amended and supplemented ONLY to the following extent:

TO ADD:

- (i) Provided however, it shall be an exception to this provision and parking shall be permitted where curbing is painted yellow upon West Water Street at Main Street in front of the Catholic Church, for elderly and/or physically disabled persons in attendance at said Church, during and for a period of thirty (30) minutes immediately preceding and for a period of thirty (30) minutes immediately following, services and events at said Church.

directly below existing (a)(14) -- that provision that states:

(a) No person shall stand or park a vehicle, except when necessary to avoid conflict with other traffic or to comply with the provisions of this Traffic Code, or while obeying the directions of a police officer or a traffic control device, in any of the following places:

(14) At any place where signs prohibit stopping, standing or parking, or where the curbing or street is painted yellow, or at any place in excess of the maximum time limited by signs;


(Provisions (a)(1) through (19) and (b) of said Section Number 351.03 shall otherwise remain in full force and effect.)

2. Effective Date: This ordinance shall take effect at the earliest date allowed by law.


