

RESOLUTION 20-16

A RESOLUTION SETTING WAGES FOR EMPLOYEES NOT OTHERWISE COVERED BY CONTRACTS

WHEREAS, the Village of New Lexington, Ohio deems it necessary to provide for the rate of pay for the employees who are not otherwise covered by contracts:

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of New Lexington, Ohio as follows:

Section 1: That effective the pay period beginning December 20, 2020 the following employees shall perform the duties required of their respective position for the base pay rate as follows:

Section 2: That the Lead Operator position for the Public Service Department will receive an additional \$0.25 per hour in addition to the above base rate. Selection, Qualifications and Duties of the Lead Operator are determined by the Village Administrator.

Section 3: That any and all ordinances and resolutions inconsistent with the resolution are hereby repealed to the extent that they are inconsistent with this resolution.
