

RESOLUTION 21-12

A RESOLUTION DECLARING THE NECESSITY FOR A LEVY OF TAX IN EXCESS OF TEN MILL LIMITATION AND DECLARING AN EMERGENCY

A majority of the members of the Village of New Lexington, Perry County, Ohio, concurring therein, BE IT, THEREFORE, RESOLVED:

Section 1: That the amount of taxes within the ten (10) mill limitation (ORC § 5705.02), on the taxable property within the Village will be insufficient to provide an adequate amount for the necessary requirements of said Village, and that it is necessary for the purpose of providing funds for maintaining and operating the New Lexington Parks and Recreation that a tax be levied on the taxable property in said Village for a period of five (5) years, commencing with the 2021 tax duplicate, at a rate in excess of said ten (10) mill limitation. That the funds so derived shall be used exclusively for the aforesaid purpose.

Section 2: That it is necessary to levy the tax in excess of the ten (10) mill limitation (ORC § 5705.02, Ohio Constitution Article 12, Section 2) for a period of five (5) years, commencing with the 2021 tax duplicate, at the following rate for each year: One (1.0) Mill on each dollar of the tax valuation within the Village, which amounts to a maximum of No Dollars and Ten Cents (\$0.10) for each One Hundred Dollars (\$100.00) of such tax valuation.

Section 3: That this is a RENEWAL tax levy and shall be submitted to the electors at the next General Election held on Tuesday, November 2, 2021, and that the taxes shall be levied and collected beginning with the 2021 tax duplicate pertaining to said Village, should the majority of the electors voting on said question vote in favor thereof.

Section 4: That the Clerk be, and hereby is, directed to certify a copy of this Resolution to the Deputy Supervisor and Inspector of Elections, Perry County, Ohio, in order that suitable arrangements can be made for the submission of said question to the electors of said Village on the date aforesaid.

Section 5: That the Clerk be, and hereby is, directed to cause notice of such election to be published according to law.

Section 6: That this Resolution be declared an emergency for the reason that sufficient time is allowed for compliance with the law and submission of the issue for placement upon the ballot.
